During the tax year, the organization became aware of a significant diversion of assets totaling approximately \$10,000 due to a fraud scheme involving impersonation of one of its vendors. A third party, posing as a legitimate vendor, submitted a fraudulent invoice via email. The organization, believing the request to be valid, processed the payment before the deception was discovered. The funds were not recovered. Upon discovery, the organization reported the incident to its financial institution and consulted with the insurance company. It was also reported to the Signal Hill Police Department and to the FBI. It also reviewed the incident with its Finance Committee. As a result, the organization has implemented stronger internal controls, including enhanced vendor verification procedures and dual-approval protocols for all outgoing payments, to mitigate the risk of future fraud. No officers, board members, or employees of the organization were involved in the incident.
